



Yoga Spirit Studios Venue Hiring Policy and Agreement

When hiring any of the facilities of Yoga Spirit Studios you agree to abide by the terms and conditions set out in this document. This document covers the hire of the facility only.

Who can hire our spaces

Yoga Spirit Studios will happily hire our spaces to you if your event is a good match with our values and present no risk to our good name, our venue and our relationship with our landlord. We do not hire for parties.

Professional and public liability insurance

Please note that you must be covered by your own professional and public liability insurance to a minimum of ten million dollars (\$10,000,000). You must submit your certificate of currency at the time of your application for hire.

Hire fees & Payments (excluding 10% GST)

Times must be calculated to include your set up and break down times. These times cannot overlap with Yoga Spirit Studios class times, which can be seen on our timetable on our website.

Important Terms & Conditions-

(Please give attention to payment & cancellation Policies)

Payments-

- ✓ A 25% deposit on total anticipated hire fee is payable in advance to confirm your booking.
- ✓ Full fee needs to be paid minimum 15days prior to the date of booking.
- ✓ Payments will be done via bank transfer (details will be shared personally in invoice).
- ✓ **Cleaning Fee-** If the studio was found untidy and unclean there will \$35/hour cleaning fee will be applicable.

Cancellation Policy-

- ✓ Deposit is **non-refundable** if event is cancelled less than 1 month of date of booking.
- ✓ If event is cancelled **7 days** before the date of booking, hirer needs to pay the full amount of hiring charges. (if not paid in advance)

Other Details-

Keys

Keys can be collected and returned at the reception by arranging a time in advance.

Facilities

The venue is a yoga studio and there are minimal chairs and tables available for use. There are 3 ladies' toilets and one toilet for men. All the props belong to Yoga Spirit studio and there are separate charges for the use of Yoga mats, bolsters and blankets.

It is requested that the space be respected as sacred space. Shoes are not to be worn inside the two yoga spaces although they may be worn in reception. After your event the facility is to be left as it is found.

The rooms

The Studio Room is 8.4m x 9.7m with 10ft ceilings. It can be accessed by an external door and is very suitable for hiring for private appointments and small classes.

The Main Hall is 8.4m x 16.6m with an alcove to one side 2m x 10m. It has wooden floors and a very high dome ceiling. This room will accommodate up to 45 people for yoga and is a great space for stirring Kirtan and dance.

Food and drink

Food and drink can only be consumed in the **reception area**.

There are no kitchen facilities and no refrigerator.

It is permissible to set up a tea and coffee facility in the reception area providing these beverages are only consumed in the reception area.

There is a tap along the side of the building in the courtyard which can be used for filling an urn.

Chairs and tables

Tables which are used for the storage of our yoga props may not be used except for their current purpose.

Any chairs and tables stored in the shared space that leads to the toilets are not the property of Yoga Spirit Studios and **MAY NOT BE USED**.

Yoga Equipment: Bolsters, blankets, mats etc. are not included in hiring fee.

Toilets

Main Hall

Women's toilets are located off the reception area of the Main Hall. There is a single male toilet off the Main Hall which is also an accessible toilet. Some hirers make an agreement with participants to make the toilets unisex.

Studio Room

A door off the Studio Room leads to an area which is shared space with our landlord. Male and Female Toilets are in this space. You are not permitted to go beyond the passageway which leads to the facilities. (It will trigger an alarm!) The connecting door must be kept locked. The tables and chairs stored in this space are not the property of Yoga Spirit Studios and **MUST NOT BE USED**. The landlord reserves the right for sole use of the studio room toilets on the First Sunday every month for their own functions from noon and we try not to book out the studio room on those days. However the back hall could be in use at any other time, and therefore the toilets and shared space might be used by others.

Accessible toilet

It is a condition of our lease, and therefore of this hire agreement, that the accessible toilet off the Main Hall be made available at any time for the users of the back hall, should they have a disabled person who needs it as it is the only accessible toilet in the building complex. While this access has never been claimed, you should know that it could happen. The person requiring the toilet would need to access it by coming through the Studio Room, into the Main Hall to use the toilet that is off the Main Hall.

Candles and incense

No flames are allowed. This includes candles, burners and incense. We keep perfumes to a minimum as many people are sensitive and we do not wish to exclude them from yoga. Battery operated candles and fairy lights are provided for ambience. They use recycled batteries.

Making the building secure

After your hire period you are required to make the building secure.

- All heaters, coolers, lights, and electric appliances are off, and battery candles are off
- Door to shared space and toilets off Studio Room is locked, key left in the door
- Outside door in Studio room is locked and the bolts slid over (leave by reception door)
- Connecting door between Studio Room and Main Hall is unlocked
- Reception door is deadlocked and securely pulled shut
- Front gate is closed and deadlocked.
